The Madison County Library System (MCLS) has established reconsideration procedures to address concerns about library resources. Completion of this form is the first step in those procedures.

Instructions:

1. Before completing this form, read or view the disputed item in its entirety. Forms submitted without complete examination of the disputed item will not be considered.
2. All fields on this form must be completed in a full and meaningful way. Incomplete, cursory, or duplicated forms will not be considered.
3. A separate form must be completed for each disputed item/title. Forms containing multiple titles will not be considered.
4. The form asks you to frame your response in the context of the following policies, statutes and documents. Please review them:
